

1. INTRODUCTION

- 1.1 EasyEquities is running a lucky draw competition for all persons who post or tweet a congratulations message to EasyEquities on Twitter or Facebook for winning Top Tax Free Savings Account 2019 in the Intellidex SA's Top Stockbroker Awards which is run in partnership with the Financial Mail's Investors Monthly, tagging EasyEquities and using the hashtag "#EasyTFSA" during the Competition Period (defined below) in accordance with and subject to the terms and conditions set out below ("Intellidex Lucky Draw").
- 1.2 The Intellidex Lucky Draw is subject to the terms and conditions set out below and is subject to and must be read together with the EasyEquities Terms and Conditions.
- 1.3 The clauses in these terms and conditions that require your careful consideration are in bold font. You acknowledge that you have read and appreciated the importance of the terms and clauses in bold font.
- 1.4 Capitalised terms used but not defined herein will have the same meaning as in the EasyEquities Terms and Conditions.
- 1.5 By entering the Intellidex Lucky Draw, you agree to be bound by these terms and conditions.

2. HOW TO QUALIFY FOR THE INTELLIDEX LUCKY DRAW

- 2.1 Subject to clause 2.2 below, in order to be entered into the Intellidex Lucky Draw, during the Competition Period (defined below) you must:
 - (1) have a live EasyEquities ZAR account that has been approved for Trading by EasyEquities in accordance with the EasyEquities Terms and Conditions, including without limitation, verification in terms of the Financial Intelligence Centre Act, 2001 ("FICA"). This means that your account must be FICA verified in order for you to qualify for the Intellidex Lucky Draw; and
